Media: Original art or handcrafted items only

Entry: **New** Entrants must submit (3) digital print images or a CD containing (3) or more digital images for the purpose of being juried along with a completed application. Write your name in black marker on CD and/or prints. Entry deadline is March 8, 2018 at 5pm. A committee representative will notify finalists no later than March 15, 2018. All correspondence will be via email provided by the artist on app.

Fees: Booth space fee(**10 year anniversary special price**) is \$35 for Arts Council members and \$50 for non-members. Shared booth space is \$40 Arts Council members and \$60 for non-members. (Two or more artists may share one booth, if both have been juried and accepted.) If your application is rejected, this fee will be returned to you. Photos & CD's are not returnable. This is a rain or shine event. No provisions or refunds will be made in case of inclement weather.

Space: 10' x 10' (approx.) is allotted for single indoor spaces. 1 table and 2 chairs are available on a first-come/registered first-serve basis. Note: If your booth display is higher than 5', please let us know by marking the appropriate box on the Entry Form below. Tables must be tastefully covered and all storage units hidden or neatly covered. Booths cannot extend beyond the listed size and some may be affected by structural columns. Slightly larger outdoor space is available.

Security: Safety and security of exhibit is the responsibility of the exhibitor.
